BYLAW NO. 7 - 2010

A BYLAW OF THE TOWN OF FOAM LAKE TO AMEND BYLAW NO. 3-80 KNOWN AS THE TRAFFIC BYLAW TO REGULATE THE OPERATION OF VEHICLES.

The Council of the Town of Foam Lake enacts as follows:

Part 1 - Definitions:

1. Add:

g) "Recreation Vehicles" shall mean any vehicle, portable structure, trailer or watercraft that can be towed, hauled, carried on vehicle or trailer, or driven. It is designed to be used for travel or recreation purposes, and includes a motor home, (Class A or C), travel trailer, fifth wheel trailer, boat or any trailer used in the conveyance of recreation vehicle.

Part 5 - Parking:

1. Add:

- 5. c) No Recreation Vehicle shall be parked on a residential street or Public Property continuously for any period exceeding (72) seventy two hours. A daily penalty of \$50.00 will be assessed against the owner of the vehicle for each day the vehicle is in contravention of this bylaw. A licenced or unlicenced recreation vehicle may be parked on your property subject to the following:
 - i) Front Yard Parking a licenced or unlicenced recreation vehicle may be parked in your front yard in a legal parking spot. A legal front yard parking stall is a driveway that leads to an attached garage, or that leads to a detached garage, carport, or parking pad located in the side or rear yard. Seasonal front yard parking restrictions apply to certain types of RV's. (See below).
 - ii) The parking of any licenced or unlicenced vehicle, including recreational vehicles, on lawn or other areas of the front yard is prohibited.
 - iii) Seasonal Restrictions from October 1 to April 30, licensed and unlicenced motor homes (class A and C), travel trailers, fifth wheel trailers and boats are prohibited everywhere in the front yard, including driveways, and legal front yard parking stalls.
 - iv) Side and Rear Yard Parking licenced and unlicenced recreation vehicles may be parked in the side and/or rear yard provided that they comply with the recreational vehicle limit (2 vehicles), the requirement that any unlicenced vehicle be in operable condition.
 - v) Number of Recreational Vehicles per Property the total number of recreational vehicles per property cannot exceed two. This total includes both unlicenced and licenced recreational vehicles. For example, if you have 1 licenced RV and 1 unlicenced RV on your property, you have two recreational vehicles. You could not add any more recreational vehicles to the property.
 - vi) Unlicenced recreational vehicles must be maintained in operable condition. Operable condition means that the vehicles can start and move on its own power.

- vii) Screening/covering of vehicles licenced and unlicenced recreational vehicles are not required to be screened or covered.
- viii) Recreational vehicles must be parked a minimum of 2.0 meters (6.5') from back of the sidewalk (or the back of the curb where there is no sidewalk).
- ix) Unlicenced vehicles, including RV's cannot be parked on Town property. This includes the Town property located between your property line and the sidewalk or curb.

This bylaw shall come into force and take effect on the date of the final passing thereof.
