



BYLAW NO. 02-2024

A BYLAW OF THE TOWN OF FOAM LAKE TO PROVIDE FOR THE ENTERING INTO AN AGREEMENT WITH THE RURAL MUNICIPALITY OF FOAM LAKE NO. 276 FOR THE OPERATION AND MAINTENANCE OF THE FOAM LAKE TRANSFER STATION.

The COUNCIL of the Town of Foam Lake, in the province of Saskatchewan enacts as follows:

1. The Town of Foam Lake shall enter into an Agreement with the Rural Municipality of Foam Lake No. 276 for the operation and maintenance of the Foam Lake Transfer Station identified as "Schedule A" attached hereto.
2. Bylaw 04-2004 is hereby repealed.

Read three times by unanimous consent of Council and adopted at a regular meeting of Council this 14th day of May, 2024.

FOAM LAKE AND DISTRICT TRANSFER STATION AGREEMENT

MADE IN DUPLICATE THIS 16 DAY OF May, 2024

BETWEEN:

The Town of Foam Lake
An Urban Municipal Corporation of and in the
Province of Saskatchewan,

*Hereinafter referred to as
"Town of Foam Lake" the part
of the first part:*

The Rural Municipality of Foam Lake No. 276
A Municipal Corporation of and in the
Province of Saskatchewan,

*Hereinafter referred to as
"R.M. of Foam Lake" the party
of the second part:*

WHEREAS the parties named above desire to continue to associate with each other for the purpose of further organizing, maintaining, and operating the Foam Lake Transfer Station.

NOW THEREFORE the agreement witnesseth that in consideration of these presents and covenants, promises and agreements hereinafter contained, the parties jointly and severally agree as follows:

1. That the Town of Foam Lake shall administer the daily operation of the transfer station under the recommendations of the Foam Lake and District Transfer Station Committee and passed at the Town of Foam Lake and R.M. Of Foam Lake Council meetings.
2. The Town of Foam Lake shall bear 70% and the R.M. of Foam Lake shall bear 30% of the general operating expenses.
3. The Town of Foam Lake shall be responsible for the rental, mileage, and tonnage charges on the Town of Foam Lake bins as contracted with Ottenbrite Sanitation Services. The R.M. of Foam Lake shall be responsible for the rental, mileage, and tonnage charges of the R.M. of Foam Lake bins as contracted with Ottenbrite Sanitation Services.
4. If a surplus on general operations is realized the share shall be 70% Town of Foam Lake and 30% R.M. of Foam Lake.
5. The Committee shall be made up as follows:

Four (4) members from the Town of Foam Lake, appointments may be two from the elected Town Council, the Town Foreman, and the CAO; and two members from the R.M. of Foam Lake, appointments may be from elected RM Council and/or staff, terms being four years.
6. Duties of the Committee:
 - a. Recommend to the perspective Councils purchase of equipment as the Committee sees necessary.
 - b. Review matters brought forward by either Council

7. Minutes of the Committee shall be distributed to both Councils.
8. The recording secretary of the Committee shall be the Administrator of the Town.
9. The Town shall be the receiver of expenses and revenues derived from the transfer station and distribute the operations 70%/30% split.
10. An amendment to the agreement may be made only by the majority consent of the participating members of the Transfer Station Committee upon municipal council's approval.
11. If for any reason it becomes necessary to dissolve this agreement the assets that are available after paying the liabilities shall be paid to the respective communities at a 70%/30% split.
12. The parties agree to perform and do all acts necessary in order to ratify and confirm this agreement and in particular the parties agree to pass a complimentary bylaw authorizing the execution and performance of this agreement.
